229/25 Public Participation

Two members of the public gave a talk on behalf of the Save Kilburn and Horsley Greenbelt Campaign. The talk covered the proposed hosing development AVA/2925/0587 and the campaign objects to the proposal. The campaign has its own Facebook group and website. The representatives asked if the Parish Council could share their campaign details in the Wudhus News and website. The representatives also informed that there is a Go Fund Me page and any grants towards the campaign would be greatly appreciated. It was agreed to discuss the request at the next meeting.

The PCSO's confirmed that there had been a couple of reports relating to vehicles and arrests had been made. There had also been reports of a couple of deliberate fires and a potential threat on the street reported.

The PCSO's discussed the reported potential threat on the street incident and confirmed that all was ok with the property and is not an ongoing issue. The Parish Councillors passed on their thanks to the Police who were present on the evening of the evacuation. The Parish Councillors confirmed their disappointment at the nonexisting emergency evacuation plan for the Parish and would like this to be feedback to the Police.

Cllr Pizzey confirmed that Smalley Parish Council has been contacted by the Fire department regarding putting up CCTV in relation to the deliberate fires that have occurred. Cllr Pizzey thanked Cllr Higgins for being pro active in arranging temporary accommodation for people that were recently evacuated from their homes. DCC have thanked the British Legion for providing accommodation.

Cllr Pizzey informed that the next Speedwatch session is to be confirmed.

Cllr Pizzey also informed that the next full Council meeting is to be on the 6th and reorganisation is to be discussed.
